Unique Digital Address And Digital Repository In Public Administration

Abstract: Person name will not be unique in the any part of the word, we will find more than one person with same first name and last name. Email id is digital address that person being recognized and used to communicate in today's world. As email address, will be created by using person names, as person name is not unique, so email address also cannot be unique which leads to confusions in communication and identity. This paper is intended to illustrate and demonstrate implementation and usage of unique digital address and digital repository.

I. INTRODUCTION

We are all leaving in digital world and being global citizen, we use electronic communication as major communication channel. In this digital world, each country is using email as prime communication channel for their internal correspondence with their citizens and with foreign citizens for international correspondence. Email address is being formed by names of the person particularly in official communication. As the same name of the person are being repeats within and across the generations, so email id will have random additional text suffixed with additional characters like 007.2.1947.2000.123.99 etc. to ensure uniqueness. Here we want to introduce new concept of generating & usage of unique email id across the nation and the world, this can be primarily used for official communication. This can also be used to create unique digital repository.

II. CURRENT CHALLENGES

As name of the person is not unique so creating unique email address is near impossible, email ids being formed using names but with little suffixed text to make unique, which may not be meaningful and difficult to recognize right person. Due to this email id similarity, email id owners face many challenges in correspondence as listed below.

- ✓ Unknowingly one person email might be sent to another person.
- ✓ Irrelevant recipient may come to know other person's confidential or Personal Information.
- ✓ Actual recipient may not get right information at right time.
- ✓ Currently email services has been provided by third party services, which may be stopped by the email service provider or due to policies of the country or may move to paid services.

Example: In 2001, usa.net was moved to paid mode. Many users lost their email id.

✓ Data security policy under discretion of third party email service provider, which may change over period.

III. GENERATION OF UNIQUE DIGITAL ADDRESS (EMAIL ADDRESS)

Every country is following its own standard process to identify its citizens and foreign citizens uniquely. Let's see some popular countries' unique identification examples

- ✓ Government authority can generate unique email id by prefixing country ISO code and by suffixing government website domain to trimmed unique ID number.
- ✓ As email address need to have alphabet as first character, so prefixing ISO code is required.
- ✓ Prefixing ISO code also makes it unique across the world.
- ✓ Suffixed domain name can be decided by government authority. Example:

IV. IMPLEMENTATION METHODS

Unique digital address will have unique email id and corresponding email box (storage).

- This can be implemented in two modes
- ✓ Complete Interactive Mode
- ✓ Partial Interactive Mode
- ✓ Read-Only Mode

A. COMPLETE INTERACTIVE MODE

Under Complete Interactive mode, Government Authority will create an email box and allow user to use as the authorized email communication channel with Government for legal activities.

This method follows same email services as now being provided by most popular email service providers. Citizen will

get user id and password to access his/her dedicated email box.

ADVANTAGES

- ✓ Secured dedicated repository for important documents that user can preserve for his lifetime.
- ✓ User can send his/her personal non-Government authorised documents to this mail box for his/her personal references.
- \checkmark User can send emails from this mail box to anyone.

DISADVANTAGES

- ✓ Mailbox will be used by user as primary mail box; user mail box may need large amount of storage.
- ✓ As user, can send emails from this email id to anyone, which impacts the network traffic.
- ✓ As user is free to feed any document to mail box, it may bring virus into system.

B. PARTIAL INTERACTIVE MODE

Under Partial Interactive mode, Government Authority will create an email box and allow user to send emails from affiliated email ids.

In this mode, citizen will get email box which can be used as read purpose means citizen can download the contents from email box and allowed to send emails from affiliated email addresses which can be controlled by user, at account settings level.

ADVANTAGES

- ✓ Secured dedicated repository for important documents that user can preserve for his lifetime.
- ✓ User can send his personal non-Government valid/authorised documents to this mail box for his/her personal references.
- ✓ Acts as life time digital locker for government approved/sanctioned documents related to user and can maintain user's personal documents in same email box.

DISADVANTAGES

- ✓ Mailbox will be used as semi interactive, user may push many documents which may not be useful.
- ✓ As user, can send email from his side there is no control on the storage and maintenance.
- ✓ As user is free to feed any document to mail box, it may bring virus in to system.

C. READ-ONLY MODE

Under Read-Only mode, Government Authority will create an email box and allow user to use as the authorized repository for references in a read only mode. This method will allow user to use his email box just for reference and only Government authority can send emails to email box. All other emails will be rejected.

ADVANTAGES

- Most secured document repository of a person that can be referenced lifelong.
- Only Government authority systems will send emails, repository will consume less storage and most relevant information will be preserved.

DISADVANTAGES

- ✓ Repository will be read-only, user cannot contribute from his end.
- ✓ Only inserts/appends, no updates.

By considering the efficient and optimized usage, we would like to proceed with Read-Only

Mode as most preferred approach as initial implementation. We can move to Interactive or partial interactive mode based on the feasibility.


V. EXECUTION PROCESS

Assumptions:

- ✓ Execution activity will be taken care by dispatch section of Government Authority.
- ✓ In every Government process, applicant's Unique Identification Number (UIN) should be specified in the application as mandatory.
- Every Government dispatch office should be well equipped with computer facility having scanner & internet.

EXECUTION

- Every Government application should have UIN specified by applicant, UIN will be associated in every step of process as one of the mandatory field, this value can be encrypted if required.
- Dispatch section employee should scan the approved or signed document.
- ✓ Dispatch section program should pick UIN associated with application request and compose the unique email id by prefixing predefined country ISO code and suffixing email domain value.
- Email with attached scan copy of approved or signed document will be sent to composed unique email id.



VII. UTILIZATION

With presumption of Read-Only mode implementation, utilization of unique id at Government authorities in different phases of human life cycle as below.

GENERATING UNIQUE ID

Unique id should be generated immediately after allocation of national unique identification number. Email box also created at that time only.

PHASE: BIRTH & INFANT

In this phase below specified documents are being issued by Government authority and should be sent to document recipient. The very first document of a baby will be a birth certificate. Since UIN for a baby cannot be generated at that time, birth certificate will be sent to parents of a baby.

F. PREVENTION OF DOCUMENT MALL PRACTICE

Document mall practice will be become impossible as copy of original document will be available in Government Digital Repository and can be cross verified immediately and document under Government repository will be considered as golden copy/record.

G. PROPERTY/VEHICLE SALE-PURCHASE

The biggest frauds will happen in property related transactions. Most of the individuals will suffer due to unclear titles and hidden transactions. With this implementation individual, can refer to the complete history of the property or vehicle. In any property/vehicle purchase transactions both buyer and seller will get copy of the document.

Enabling my unique digital address and digital repository will make every citizen as digital unique universal citizen. This will prevent ambiguity in email id due to duplicate names within country and across the country. This will also help to build his/her personal digital repository for life time events.
